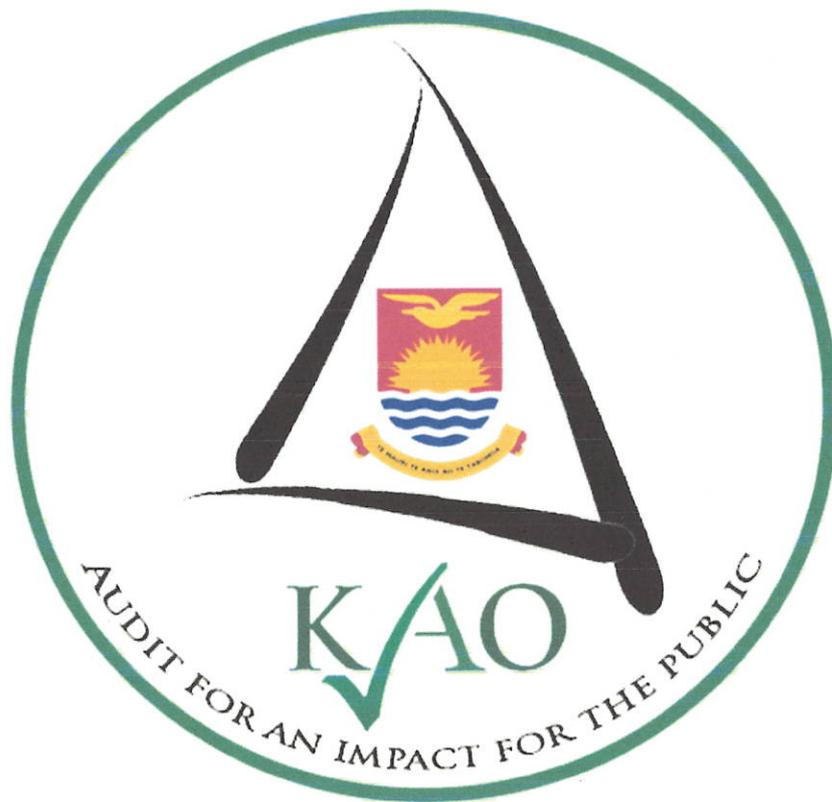

INDEPENDENT AUDITOR'S REPORT

**To the Readers of
Kiribati Copra Cooperative Society Ltd (KCCS) Financial Statements
for the years ended 31st December 2013-2015**

I have audited the Financial Statements of **Kiribati Copra Cooperative Society Ltd (KCCS)** for the years ended 31st Dec, 2013 to 2015 in accordance with sec 114 (2) of the Constitution, Part VII, Sec 42(4) of the Public Finances (Control and Audit) 1981, Sec 22(1) of the Kiribati Audit Act, 2017. The Financial Statements comprise of the following:

- Statement of Financial Performance
- Statement of Financial Position
- Notes to the Accounts

Disclaimer of Opinion

I do not express an opinion on the accompanying Financial Statement of the Kiribati Copra Cooperative Ltd for the years ended 31st December, 2013 to 2015. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

Basis for Disclaimer of Opinion

The following issues formed the basis of our disclaimer opinion:

- Matching of the General Ledger balances to the Financial Statements for the years 2013 to 2015 showed significant variances. This has raised doubts as to the accuracy of the Financial statements for those years.

- KCCS had not provided its Cashflow Statement for the years ended 31 Dec, 2013-2015.
- In addition, we also noted a lot of missing documents as listed below:
 - Fixed Asset Register 2013-2015
 - Updated Individual Debtors card 2013-2015
 - Deposit books for 2013-2015
 - Bank Reconciliation for 2013 and 2015
 - Board minutes for 2013-2015
 - Payment Vouchers for the years 2013 to 2015.
 - 2013 Cheque butt for months; Jan, Feb, June, July and August
 - 2014 Cheque butt for months: Jan and Feb
 - 2015 Cheque butt for months: Jan, Feb, Mar, June and July.

I have conducted my audit in accordance with International Standards of Supreme Audit Institutions (ISSAI). My responsibilities under those standards are described in the Auditor's Responsibilities paragraph of my report.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with IFRSs, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Cooperative's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so. Those charged with governance are responsible for overseeing the Company's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Cooperative's financial statements in accordance with International Standards on Auditing and to issue an auditor's report. However, because of the matters

described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are independent of the Cooperative in accordance with the ethical requirements that are relevant to our audit of the financial statements in Kiribati and we have fulfilled our other ethical responsibilities in accordance with these requirements.

Communication with those charged with governance

I communicate with the Board of Directors and Managements regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that I identify during my audit.

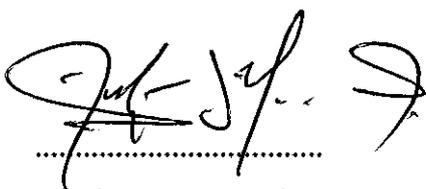
Report on other Legal and Regulatory Requirements

KCCS lodged its 2013 to 2015 Financial Statements for audit on 24th August 2018, therefore indicated KCCS's non-compliance with Section 20 of SOE Act 2013.

Independence

Section 114 (4) of the Kiribati Constitution stipulates that the Auditor General shall not be subject to the direction or control of any other person or authority.

Other than the audit, we have no relationship with or interest in KCCS.

1. Work in process inventory

This represents the cost incurred in working on goods that have not been completed as of the balance sheet date.

2. Finished goods inventory

This represents the total cost incurred to produce the units that are completed but have not been sold as at the balance sheet date. The finished goods inventory usually includes all three cost elements, raw materials, direct labor and factory overheads.

1.6 Doubtful debts:

Provision on doubtful debts is to be determined on the following rates:

Total Receivables

One year

Two years

Three years

1.7 Turnover:

The turnover should always represent the sales of goods on cash and at invoiced value net return claims.

Statement of Significant Accounting Policies

The Company Financial Statements are to be prepared under the historical cost convention and in accordance with an International Accounting Standards applicable in Kiribati. As a registered company, the accounting practices or standard must also comply with the requirements of the Company Act. The accrual accounting concepts are therefore be applied to all transactions of the company.

The most important policies to be used by the company are as follows:

1.1 Historical Cost:

The accounts as stated above are to be prepared under the historical cost convention and to comply with the international Accounting Standards which applicable in Kiribati.

1.2 Depreciation:

Depreciation is to be calculated using the straight line method to write down the value of fixed assets at their expected useful life. The following annual rates which are to be consistent with the existing law in Kiribati are to be used by the company.

- Motor Vehicles
- Furniture & Fittings
- Office Equipment
- Buildings
- Tools, Plant & Equipment

1.3 Stocks

Stocks is to be stated at the lower cost and realizable value and to be determined on the First In and First Out basis and also to include freight, duty levy and other handling cost.

1.4 Obsolete:

Provision is to be made for obsolescence taking into accounts the relevant overheads of their being imported or manufactured.

1.5 Inventories:

It is therefore most appropriate for the company to maintain three different inventories as follow:

- Raw materials inventory

This represents the cost of direct materials and suppliers which are on hand at the balance sheet date. These raw materials have not yet been used to manufacture the product of the company.
