INDEPENDENT AUDITOR'S REPORT

To the Readers Of

Kiribati Coconut Development Limited Financial Statement

For the year ended 31 December 2017-2023

I have audited the Financial Statements of Kiribati Coconut Development Limited (KCDL) for the year ended 31st December 2017-2023 as required under sec 114 (2) of the Constitution, Part VII, Sec 42(4) of the Public Finances (Control and Audit) 1981, Part IV Sec 23 of the SOE Act 2013 and Sec 22(1) of the Kiribati Audit Act, 2017. The Financial Statements comprise of the following:

- Statement of Financial Performance
- Statement of Financial Position
- Statement of Cash Flow
- Statement of Changes in Equity
- Notes to the Accounts

Disclaimer Opinion

I do not express an opinion on the accompanying financial statements of the KCDL. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

Basis for Disclaimer Opinion:

The audit was unable to obtain sufficient appropriate audit evidence to support a significant number of transactions and account balances due to the unavailability of supporting documentation. The absence of this evidence constitutes a limitation on the scope of our audit. Consequently, the audit was unable to determine whether adjustments to the following figures might be necessary:

1. Unverified Bank Account and Term Deposit Balances

The audit identified that cheque account and term deposit balances recorded in the company's books could not be verified due to the absence of bank audit certificates, bank confirmations, bank statements, and bank reconciliations. As a result, we were unable to confirm the existence, accuracy, and ownership of these balances.

Refer to Appendix 1 for further details of the supporting documentation not provided.

2. Unsupported Petty Cash Balances

No supporting documentation was provided to substantiate the petty cash balances reported in the financial statements. As a result, the audit team was unable to verify the existence, accuracy and occurrence of the reported balances. Refer to Appendix 2 for more details.

3. Unsupported Inventory Balances

Inventory records were not maintained or available for the periods under audit. Consequently, sufficient appropriate audit evidence could not be obtained to verify the existence, completeness, and accuracy of the inventory balances reported in the financial statements.

4. Trade Debtor

Supporting documentation for the sampled trade debtor transactions, totalling \$4,875,685.49¹ was not provided. The audit was unable to verify the accuracy, completeness and occurrence of the recorded balance.

5. Missing Payment Voucher

The audit identified a fixed asset-related expenditure transaction totalling \$152,876.75² for which the supporting payment voucher was not provided. Consequently, sufficient appropriate audit evidence could not be obtained to verify the validity, accuracy, and completeness of the recorded amount.

6. Unsupported Expense Transactions

The audit identified payments made to suppliers totalling \$266,603³ for which supporting documentation was not provided. Consequently, sufficient appropriate audit evidence could not be obtained to verify the validity, accuracy and completeness of the recorded payments.

7. Domestic Sales - Missing Receipts

The audit identified the domestic sales revenue totalling \$3,977.50⁴ for which the related sales receipts were not provided. As a result, sufficient appropriate audit evidence could not be obtained to verify the occurrence and accuracy of the reported amount.

8. Payroll Expenditure

The audit identified payroll expenditure totalling \$268,266.87⁵ for which supporting documentation, including pay costing for the selected pay periods, was not provided. Consequently, sufficient appropriate audit evidence could not be obtained to verify the accuracy and completeness of the reported payroll expenditure.

1. Incorrect Recognition of Fixed Asset & Overstatement of Accumulated Depreciation

The audit noted that a motor vehicle costing \$44,247.71 was incorrectly capitalised as a fixed asset in 2018, although the vehicle had not been received by the entity.

Management reversed the asset cost in 2020; however, the related depreciation was not reversed. This resulted in an overstatement of accumulated depreciation and an understatement of profit.

I have conducted my audit in accordance with International Standards of Supreme Audit Institutions (ISSAI). My responsibilities under those standards are described in the Auditor's Responsibilities paragraph of my report. I am independent of **KCDL** in accordance with the Code of Ethics for Supreme Audit Institutions together with the ethical requirements that are relevant to my audit. I believe that the audit evidence obtained is sufficient and appropriate to provide a basis for a qualified opinion.

Emphasis of Matter:

The audit would like to draw the attention of users of KCDL financial statements to the following matters stated below:

1. Inadequate Maintenance of Mill Machinery and Availability of Spare Parts

The audit noted that certain mill machinery was not operating properly and required replacement spare parts. Delays in obtaining necessary spare parts and inadequate maintenance may affect the mill's operating capacity and operational continuity.

2. Incomplete record of Fixed Assets

KCDL maintains a fixed asset register (FAR); however, it lacks key identifying information necessary for accurate tracking and verification of assets. Specifically, the FAR does not record serial numbers or any form of unique labelling that would allow assets to be clearly identified as belonging to KCDL.

3. Trade Creditor – Copra Shipping Receipts and Test Weight Certificates

The audit noted that copra shipping receipts and test weight certificates were not provided for the items listed in Appendix 8. The absence of these supporting documents indicates inadequate filing and record-keeping practices by KCDL and limits the ability

of the audit to verify the completeness and accuracy of the related trade creditor balances.

4. Fixed Asset Payments

The audit noted that supporting documentation for selected fixed asset payments was incomplete. While some supporting documents were provided, the documentation available was not sufficient to fully support the validity, authorization, and receipt of the assets purchased. For more details, refer to Appendix 9.

5. Inadequate Segregation of Duties

The audit noted weaknesses in the segregation of duties over cash collections. Salespersons/storekeepers collect cash, issue sub-RR receipts, and balance their own daily sales without independent verification, while the Cashier receives, records, prepares the deposit, and banks the funds.

No formal cash handover records or independent review were maintained to confirm the completeness and accuracy of collections. The audit also noted instances where collections from several days were accumulated before banking, increasing the risk of errors and discrepancies.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with IFRS, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Company's financial reporting process.

Auditor's responsibilities for the Audit of the Financial Statements

My objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion as required under the Public Finance (Control and Audit) Ordinance 1976 and Kiribati Audit Act, 2017. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with ISA/ISSAI will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISAs & ISSAI, I exercise professional scepticism throughout the audit. I also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the entity's ability to continue as a going concern. If I conclude that a material uncertainty exists, I am required to draw attention in my auditor's report to the related disclosures in the financial

statements or, if such disclosures are inadequate, to modify my opinion. My conclusions are based on the audit evidence obtained up to the date of my auditor's report. However, future events or conditions may cause the Entity to cease to continue as a going concern.

- Evaluate the overall presentation, structure, and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

I communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that I identify during my audit.

I also provide those charged with governance with a statement that I have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on my independence, and where applicable, related safeguards.

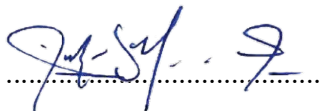
From the matters communicated with those charged with governance, I determine those matters that were of most significance in the audit of the financial statements of the current period and are therefore the key audit matters. I describe these matters in my auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, I determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

Report on other Legal and Regulatory Requirements

KCDL lodged its 2017-2023 Financial Statement on the 4th of June, 2026, which indicates that the company had failed to comply with Section 20 of the SOE ACT, 2013.

Independence

Section 114 (4) of the Kiribati Constitution stipulates that the Auditor General shall not be subject to the direction or control of any other person or authority. Other than the audit, we have no relationship with or interest in KCDL.
